SPEEDCLIMBING AM BLAUEN TURM

The Participant declare(s) with his/her signature that participation in the event is voluntary and at his/her own risk. The participant is aware that participation in the event - despite the safety precautions taken - is associated with an increased risk of injury and accident and that participation in the event requires a high level of athletic ability and a high physical fitness. The participant confirms that he/she has been informed about the safety regulations.

The participant declares that he/she is physically healthy and trained to warrant safe participation in the event. He/she represents that he/she is not under the influence of alcohol, drugs, medication or other influences. No liability is assumed for health risks of the participant in connection with participation in the event. It is the sole responsibility of the participant to have his/her state of health checked by a doctor beforehand. If a medical examination is waived, this is done at the participant's own responsibility. The participant is responsible for his/her own safety and that of third parties.

The participant shall bear sole responsibility under civil and criminal law for all personal injury, damage to property or financial loss caused by him/her or through improper or irregular use of his/her equipment or any sports equipment made available to him/her. With his/her signature, the participant declares that he/she waives any claims whatsoever to damages or injuries to his/her own person arising in connection with the event, with the exception of damages caused by gross negligence or wilful intent on the part of the organizer. This waiver is also declared by the participant for his/her legal successors or relatives, as well as any persons entitled to maintenance.

The participant acknowledges that no liability exists on the part of the organizer, sponsors and/or their vicarious agents for accidents or damage suffered in connection with the event which are caused by other participants or external third parties (e.g. visitors). With his/her signature, the participant waives any right to compensation and recourse for all accidents or damage suffered in connection with the event vis-à-vis all persons involved in the execution of the event, in particular the organizer, its vicarious agents, sponsors and their vicarious agents as well as the owner(s) of the plots of land, buildings or facilities used for the event or their vicarious agents.

The participant acknowledges that there no liability is assumed for items lost or stolen during or in connection with the event. The participant is hereby expressly advised to take out insurance cover (e.g. accident, health, theft or burglary insurance) against possible damage which may be caused by participation in the event.

The instructions of the organizer, its vicarious agents and other persons entrusted with tasks as part of the event, as well as the safety regulations, must be strictly observed. The participant is aware that there is a strict ban on alcohol for athletes during the event. In the event of a breach or non-compliance with the instructions or safety regu-

lations, the participant acknowledges that he/she will be excluded from further participation in the event or may be expelled from the event location, without the participant being able to assert any claims for damages whatsoever against the organizer or the sponsors or their vicarious agents.

The personal data of the participant will be processed exclusively on the basis of the applicable statutory provisions of the German Data Protection Act (DSG) as amended and the General Data Protection Regulation (GDPR - Regulation (EU) 2016/679). With his/her signature, the participant declares that he/she has read and received the data protection declaration which is published on site and accessible on the Internet at www.speedclimbing-bw.de/datenschutz at all times and in which all information pursuant to Art. 13 DSGVO in conjunction with Art. 16 to 21 DSGVO is comprehensively presented. The participant expressly agrees that his/her personal data - to the extent that it is required for the recording of performance/results or results management in connection with participation in the event - may be stored and made publicly accessible for archiving purposes in the public interest or for legitimate interests of the controller.

The participant expressly and voluntarily agrees to the production, publication, distribution, duplication, use and exploitation of any photographs or other picture/sound documents, of whatsoever kind produced by him/her in the course of his/her participation in the event (including preparation, post-processing and travel time) for information purposes and for the advertising purposes of the organizer or the sponsors (e.g. homepage, published (media) reports, other printed works, social media, advertising inserts and/or fan articles), and the participant transfers to this extent the relevant (exploitation) rights to which he/she is entitled to the organizer and the sponsors or the respective photographer or producer of those materials for no consideration. Any use of the recordings for purposes other than those described is prohibited. This consent is voluntary and can be revoked at any time with effect for the future.

The participant acknowledges that any (wilful) breach ascertained by the organizer will lead to immediate exclusion from the event (contest) and to expulsion from the event location (event area). He/She confirms that all information contained in the registration is correct. The participant confirms with his/her signature that he/she has fully informed himself/herself of the contents of this declaration and has read it before signing it.
